NOTIFICATION

Provision is made for any person having any grievance relating to the right of child under the Act, to make a written complaint to the local authority having jurisdiction vide Section 32(1) of the Right of Children to Free and Compulsory Education Act, 2009.

Section 32(1) Provides that "After receiving the complaint under sub-section (1), the local authority shall decide the matter within a period of three months after affording a reasonable opportunity of being heard to the parties concerned."

In order to act upon such complaints, there is a need to designate appropriate authority by the Government.

District Level Education regulating Authority in each district were constituted under Rule 16 of Karnataka Educational Institutions (Classification, Regulation and Prescription of Curricula, etc) Rules, 1995.

In the light of the above, it is felt appropriate to adapt the provision contained in Rule 16 under the Karnataka Educational Institutions (Classification, Regulation and Prescription of Curricula, etc) Rules, 1995, and declare the District Level Education Regulating Authority as the grievance redressal authority at the district level for the purpose of Sections 32 (1) and 32(2) of the RTE Act 2009.

The Government of Karnataka hereby designates the said authority as the prescribed authority under section 32 of the RTE Act, as grievance redressal Authority.

The Authority shall pass orders within 3 months of the written complaint filed with the authority, after affording a reasonable opportunity of being heard to the parties concerned.

The orders passed by the district Level Education Regulating Authority, would be binding on the Chief Executive Officer of Zilla Panchayat, DDPI and BEO for the purpose of Rule 23 of The Karnataka Right of Children to Free and Compulsory Education Rules, 2012 read with Section 36 of the Right of Children to Free and Compulsory Education Act, 2009.
